CATeam Update: Sgt Sadauskis	Rochesterfest: Quiet and uneventful. Significant changes in Security the past couple years may have contributed to making it a more safer event: snow fences, more police presence, etc.	Get CAPS Survey results in to assess community need and concerns.
	<u>Prostitution Rings</u> : Sting operations continue. Dynamic has changed, where outside people are coming into the community to do this line of work. Rochester is lucrative on the street. Sex acts are much higher here without nearly as much competition. Their website for advertisement is known.	
	<u>Crimestoppers Program:</u> People today are into social media and more information is coming from photographs, cameras, etc. How do you get that out to the community i.e. "Do you recognize this person?" Perhaps a web page through www.coptalklive.com will be available to address these concerns.	
	Beer Bellyz: Calls for service are 390% more than the average bar. CATeam has met with the bar owner and Issues have been taken to the City Council. In the past 6 weeks, crowds have dropped down.

IMAA: Ron Buzard	IMAA is a nonprofit organization that's been around since 1984. It began with the influx of refugees from SE Asia and its focus is on immigrants coming into the US. The goal of the program is to 1) create stability 2) provide support services 3) build community. 75% of their focus is on family reunification, 15% on business related immigration, and 10% on parolees (defined as refugees who flee their homeland for fear of persecution. The US accepts a certain number on an annual basis acting as a temporary asylum). IMAA is led and governed by immigrants. The 3 largest immigrant groups represented in our community are Somalian, Latino, and Cambodian. Growing is the Sudanese population - arriving as refugees. It was discussed that some immigrants have a negative perspective of police so having an officer present might help at their focus groups. The immigrant perspective was discussed and how immigrants often feel "We tend to project our feelings onto them."	The IMAA invites anyone in the community to attend their meetings (twice a month) and hear the stories of immigrants whose lives have been affected by the services of IMAA. Contact Ron Buzard at 289-5960 x122 or go to www.imaa.net. Susan is to e-mail Ron to get a list of classes/sessions available at the IMAA and distribute to the rest of the CAPS members. Ron will look at the CAPS survey and have the caseworkers test it since there are illiteracy issues. They will give us feedback. Another pool of people to consider for insight on issues of crime would be interviewing those in jail. They could give us feedback in ways that are different. Would letters need to be written to the judge?
